

June 10, 2002

The Mahaska County Board of Supervisors met in special session on the above date at 10:00 a.m. in the third floor conference room of the Mahaska County courthouse. Present were the following board members: Henry W. VanWeelden, Greg Gordy and Howard Groenendyk. Also present was Kay Swanson, county auditor.

Chairman VanWeelden opened the meeting with a moment of silence. It was moved by Groenendyk seconded by Gordy to approve the agenda. All present voted aye. Motion carried.

County Auditor and Commissioner of Elections, Kay Swanson, reported the total number voting on election night as 2002 votes cast at the polls with an additional 288 absentee votes counted. There were 5 absentee ballots and 1 paper ballot counted by the special precinct board making a total of 2,296 votes cast. There were 14,555 registered voters eligible to vote on Tuesday, June 4, 2002 which equaled 15.77% that voted. There were 2,035 Republican voters; 258 Democrat voters and 3 Iowa Green Party voters. There were 320 absentee ballots requested of which 288 were returned in time to be counted; 8 not returned at all; 19 not returned in time to be counted.
